Subj: Extension of Provisional Affiliation to the above said school beyond 31.03.2013

Sir/Madam,


This is with reference to your online application executed on 22/03/2013, on the above subject.

In this connection, I am directed to convey the sanction for extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior Secondary Certificate Examination for a further period of Five year(s) i.e. 01.04.2013 to 31.03.2018 subject to the fulfillment of the following conditions:-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/Affiliation Bye-Laws of the Board.
3. The School is required to apply online for further extension of affiliation along with the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month subject to maximum of Rs. 50,000/-.
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board. (Amended Rule 15.11)
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not be generalised as the optimum number as under from Pre-Primary to Class XII :-

Campus area	Enrolment	No. of Sections (pre-primary to X)	No. of Sections in XI & XII
1.0 acre	1250	02 in each class	04 in class XI & XII
1.5 acre	1875	03 in each class	06 in class XI & XII
2.0 acre	2500	04 in each class	08 in class XI & XII

If a school running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.

6. The school will strictly adhere with all rules regarding safety of students including fire fighting, Drinking water, Sanitation, Transportation, etc.
7. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.
8. Other conditions are enclosed as per Annexure 'A'.
9. Special conditions to be complied within three months:-
- The school is required to maintain section teacher ratio 1:1.5 for each level.
 - The school is required to ensure that pay-scales, DA and other admissible allowances are being paid either at par with the corresponding categories of employees working in the State Govt. Schools or as per VIth Pay Commission of Government of India and disburse the salary through ECS facility as per norms of the Board.
 - School is required to maintain Reserve fund in the joint names of the Manager of the school concerned and the Secretary of the Board in the scheduled Bank according to the strength of the students and send a copy of the same.
 - School has yet not preferred its reply with regard to complaint/grievance as made by Mr. Bhaskar Chand vide dated 17/06/2013 and which was forwarded to the school vide office letter dated 24/10/2013(copy enclosed). Therefore, an explanation towards not submission of reply against the said grievance/complaint is required along with school reply.
 - Enrollment in some sections are more than prescribed limit. It should be as per Affiliation Bye-laws.
- ** The Extension of Provisional Affiliation upto Secondary level/Senior Secondary level w.e.f. 01/01/2013 to 31/03/2018 has been granted Provisionally subject to the conditions that the school will pay the pay scale and allowances which should at least be at par with corresponding categories of teachers employed in government institutions of the State Govt. or as per scale prescribed in 6th Central Pay Commission of Govt. of India in respect of its teachers and the school will make payment through ECS mode & will appoint teaching & non-teaching staff possessing the qualifications prescribed for each post in the Affiliation Bye-Laws. Further, the school is required to submit EPF challan in respect of its employee to the Board.


